Burning must not take place (a) during an advisory of threatening atmospheric conditions or any other air pollution emergency episode or (b) during a period when forest fire danger is high or extreme, if the Open Burning is within 100' of woodland or of grassland adjacent to a woodland. 2. The effective CT "Open Burning Guidelines", applicable sections of the CT Administrative Regulations for the Abatement of Air Pollution and applicable local ordinances and regulations must be followed. 3. Burning must cease if so directed by the local Open Burning Official or CT DEEP. 4. No objectionable odors or excessive smoke may be created. All reasonable measures to assure complete combustion are to be taken. 		<ol style="list-style-type: none"> 5. All reasonable safety precautions are to be taken, including the clearing of grass and trees in the burning areas, wetting down surrounding areas and placing fire extinguishers. 6. Only these materials and those quantities specified above may be burned. 7. This certificate must be immediately available at the burning site at all times during the burning. 8.
